

# City of Waldport Business License Application

It is unlawful for any person who is not exempt from buying a license under the provisions of this chapter or expressly exempted by any other State or Federal law to conduct, engage in, carry on or practice any business, trade, occupation, profession or calling within the corporate limits of the City of Waldport, without securing a license from the City Recorder and paying the fee prescribed by City Council resolution. (Section 5.04.020 WMC)

**A transient business license for a 3 month period may be obtained for \$35 in lieu of the annual fee below.**  
If applicable, skip lines 1 through 14, sign and submit the application with a \$35 fee for a 3 month business license.

## Annual Business License Fee Calculation

The annual fees are assessed on a fiscal year beginning July 1st and ending June 30<sup>th</sup>. No rebate will be made regardless of whether or not the licensee remains in business for such period of time or ever commences business at any time during the fiscal period.
